II. Statement of Claim

This is a case in which a Newton County Sheriff's deputy sheriff, one Corporal Barnes, came out on a call by Plaintiff Martin Lindstedt and Defendant Michael Lindstedt's sister, Susan Lindstedt Bessman to make sure that a verbal altercation didn't turn violent. When this Deputy Sheriff came out, he immediately took sides on behalf of Defendant Michael Lindstedt, encouraged Defendant Michael (Mike) Lindstedt to go ahead and sell Plaintiff's and Defendant's mother, Martina Lindstedt's house. Furthermore, in addition to conspiring with Defendant Lindstedt, Defendant Cpl. Barnes overtly threatened Plaintiff Lindstedt with arrest even after listening to Martina Lindstedt say numerous times that she didn't know about having Mike Lindstedt sell her house. This was contrary to Cpl. Barnes' assertion that he would let Martina Lindstedt decide the matter. Cpl. Barnes actually seemed to take part in trying to convince Martin Lindstedt to allow Michael Lindstedt to sell her house on Saturday, and, furthermore, to sell the entire farm as well.

Plaintiff Lindstedt thinks that it should be unlawful for a county law enforcement official to encourage any party that has a temporary power of attorney to sell property belonging to one of his senile old parents, then convert the proceeds to his own pocket, and threaten another child of that parent with false arrest and incarceration for objecting to this fraud by someone looking to loot his mother's assets. Plaintiff made it quite clear that he would be filing a lawsuit on this matter, going through lawful means to stop further asset stripping necessary for the support of his mother, and yet Cpl. Barnes 'thinks' it is lawful and moral to act as a regime-criminal thief in

aiding the des titution of the elderly based upon a claim by one party that he has power of attorney and thus can do whatever he wants.

The Newton County Defendants (Newton County, Sheriff Ken Copeland, Cpl. Barnes) are being sued in their official and personal capacities.

Furthermore, there is a 41 minute 8 second digital audio recording taken on an mp3 player of the events on Feb 18, 2013 starting on 4:52:45 pm on wav format which will be on display on Plaintiff Martin Lindstedt's Church web page for this Court and everyone else to listen to in its entirety. Defendant Cpl Barnes was quite aware that this recording was being made, as was Defendant Mike Lindstedt, even though unhappy about it.

III. Relief

Plaintiffs want this Court to remind the Newton County Sheriff's Department that it doesn't get to take sides in a dispute, especially when one of the parties is trying to sell the family homestead belonging to a senile elderly woman who on the phone when contacted says that she "Don't know" if she wants her son, who has probably already stolen \$150,000 of her money, to sell the family home, much less encourage the thieving son to sell the farm as well. And then, to cover up for that malfeasance, treasonously threatens to engage in felonious restraint under color of law and false imprisonment because another son objects.

Furthermore, in order to minimize damages, this Court can and should place a restraining order upon Defendant Michael Lindstedt to not sell or give away any of our mother, Martina Lindstedt's real and personal assets until such time as a Missouri state court can determine whether or not to apply a guardianship over Martina Lindstedt. If there are no further damages due to a guardianship in which Martina Lindstedt's modest needs are taken care of without any necessity for selling the family farm and house, and Defendant Michael Lindstedt cannot convert the proceeds to his own use, then there should not actually be any actual damages.

Whether punitive damages for reckless and morally depraved criminal behavior on the part of Cpl. Barnes and Newton County and their animal Sheriff's Department will be for a jury to decide. *A jury trial is requested/ demanded.*


