SUMMARY OF CASE AND REQUEST FOR ORAL ARGUMENT

Pastor Martin Lindstedt, ArchBishop of Missouri for the Church of Jesus Christ Christian, made up with his sister in Nov. 2012 and so Pastor Lindstedt's brother, Michael Lindstedt and his girlfriend Crystal Courtney, decided to sell their mother Martina Lindstedt's farmhouse so that she couldn't return from Mike Lindstedt's house in Midland, SD 800 miles away from Granby Missouri. Mike Lindstedt stashed her away there so that he could embezzle her estate of \$300,000.

On Feb. 18, 2013, Martin Lindstedt went out to the farm and Susan Lindstedt called the Newton County Sheriff because Mike has been violent. Cpl Barnes knew Pastor Lindstedt because the Newton County authorities has a policy of driving Pastor Lindstedt out of Missouri. Cpl Barnes threatened to arrest Pastor Lindstedt. Whereupon Lindstedt filed the original civil complaint on 22 Feb 13 to forestall the sale, which was successful in that the farmhouse wasn't sold because of the lawsuit. Whereupon Pastor Lindstedt and Susan Lindstedt-Rohde filed to get guardianship of Martina Lindstedt. Judge Kevin Lee Selby, probate judge appointed Attorney Terry Neff as guardian ad litem. Mike Lindstedt killed through abuse and neglect Martina Lindstedt on April 5, 2013 before the case was heard.

Revised Missouri Statutes (RSMo) provide that biased judges can to be removed upon affidavit. Judges Kevin Selby and Timothy Perigo refused to obey those Missouri Statutes. So these lawyers were added to the amended suit Sept. 26, 2014. On Feb 26, 2015 Judge Baugh dismissed the case against the two judges and the lawyer. Pastor Lindstedt appealed in April 2015, this Appeals Court denied for lack of jurisdiction. Judge Baugh proceeded to carve up the rump case like a roast, dismissing the Newton County taxpayers, then Sheriff Ken Copeland, Cpl Barnes, Mike Lindstedt and Crystal Courtney. The final judgment on Jan. 19, 2015 dismissed all Defendants, hence this Appeal by Pastor Lindstedt.

Judge Stephen R. Baugh is of the opinion that policemen, judges, lawyers appointed *guardian ad litem* have either limited or absolute immunity from civil suit upon various pretexts and precedents. Pastor Lindstedt and Lindstedt's Church agree that whoever is in power gets to say what the law is, and thus these pretexts and precedents can be usefully applied to exterminate the current regime defendants upon a successful and inevitable regime change. However, this Appeals Court should have the option of trying to restore color of rule of law by taking this entire case with all the Defendants to trial by jury back at the district court level. Hence this appeal.

Appellants request oral argument of thirty minutes as this 'Martina's Hovel' case might be as much of a landmark case today with important implications for this Mighty Evil Empire as was "Naboth's Vinyard" in the Ninth Century B.C. had, not only for Ancient Israel, but as policy which has always decided the eventual fate of revolution and civil war ending every criminal regime pretending to a legitimacy it never possessed as mentioned in the Holy Bible.

In accordance with Fed.R.App.Proc. 26.1, this Church Corporation has no parent corporation or publicly held corporation or has any stock outstanding or held whatsoever.

JURISDICTIONAL STATEMENT

On Feb. 22, 2013, Pastor Martin Luther Dzerzhinsky Lindstedt, ArcchBishop of Missouri for the church corporation "The Church of Jesus Christ Christian / Aryan Nations of Missouri" filed the original civil complaint against Defendants Michael Lindstedt, Pastor Lindstedt's brother, Crystal Courtney Mike's girlfriend, Corporal Oren Barnes of the Newton County Sheriff's Department, Sheriff Ken Copeland, and Newton County and the Newton County Sheriff's Department for violation of civil rights for threatening to arrest Pastor Lindstedt under 42 U.S.C. § 1983.

Later, on Sept 26, 2014, Pastor Lindstedt made an amended complaint adding Newton County judges Kevin Lee Selby and Timothy Perigo for violating Missouri Statute removing them for cause upon affidavit from the probate case now that Martina Lindstedt was dead and presumably killed by Mike Lindstedt not wanting to bring Martina Lindstedt back to Missouri and lose his sole guardianship. Attorney Terry Neff, the incompetent guardian ad litem was sued because it was suspected that Neff had

conspired with Mike Lindstedt to refuse to bring Martina Lindstedt back to Missouri for mental evaluation. The hope was that in suing these parties that the judges would obey Missouri law and have the probate settled by a neutral judge outside the circuit.

On Feb. 26, 2015, Judge Stephen Baugh dismissed the case against the two judges Selby and Perigo and the lawyer Terry Neff. Pastor Lindstedt went through the Rule 59(e) Motions which were denied on March 30, 2015

March 31, 2015, Judge Baugh proceeded to carve away the deep-pockets by demanding that the Newton County Commission and Sheriff's Department "show cause." They proceeded to hire Ron Mitchell of Blanchard-Mitchell, lawyers for the Southwest Missouri regime criminals who filed motions to dismiss those who hadn't even filed any defense motions previously.

On April 27, 2015, Pastor Lindstedt filed a Notice of Appeal to this Appeals Court and paid a filing fee of \$505. This Court claimed a lack of jurisdiction to hear this interlocutory appeal and refused the Petition for Re-Hearing. On June 26, 2015, Judge Stephen Baugh ruled to "Dismiss for Failure to State A Claim" against the Newton County Defendants, even though lacking jurisdiction because the Appeals Court Mandate wasn't officially filed until June 30, 2015.

After filing some more Rule 59(e) Motions to Alter and Amend,
Stephen Baugh decided to finish off the case altogether by filing Orders to
Show Cause on October 19 & 20, 2015 as to why the case against
Defendants Sheriff Ken Copeland and Cpl Barnes and Michael Lindstedt
and Crystal Courtney shouldn't be dismissed, even though none of them
ever had made any real defense. Pastor Lindstedt responded and on Nov. 12,

2015 Judge Stephen Baugh dismissed the last original defendants and the Clerk signed off that every Defendant had gotten away free. Pastor Lindstedt filed a Rule 59(e) Motion to Alter or Amend that Judgment on Dec. 9, 2015. On Dec. 28, 2015, Deputy Missouri Attorney General Brandon Laird filed Suggestions in Opposition. On Jan. 14, 2016 Pastor Lindstedt filed reply suggestions to Brandon Laird's Suggestions. On Jan. 19, 2016, Judge Stephen Baugh filed a final judgment ORDER denying the Rule 59(e) Motion, thus finishing off this case at the district court level. On Feb. 16, 2016, Pastor Lindstedt filed a timely Notice of Appeal, which was accepted by this Appellate Court and given a briefing schedule. Thus this Appeal is from a final order or judgment which has disposed of all parties' claims at the district court level, cf. Fed.R.App.Proc. 28(D).

This Appeals Court also has jurisdiction under 28 U.S.C. § 1291.

STATEMENT OF ISSUES & ARGUMENT

Appellant Pastor Lindstedt and Lindstedt's Church present the following main issues for review:

1. Defendants Michael Lindstedt and Crystal Courtney, knowing of the undeclared state of civil warfare between the Newton County Sheriff's Department and Judge Selby of the Probate Court, had an "understanding" that they could kill Martina Lindstedt, confirmed on Feb. 18, 2013 by Cpl Barnes and that both the Newton County Sheriff's Department as the investigating and law enforcement agency and Judge Kevin Selby as probate and guardianship judge would protect them both from Plaintiff Martin Lindstedt and from prosecution for abuse, theft, embezzlement and eventual murder without adverse consequence.

2. Defendant Corporal Barnes and the Newton County Sheriff's

2. Defendant Corporal Barnes and the Newton County Sheriff's
Department had a policy to drive out Pastor Lindstedt from Newton
County by any means necessary, and if Lindstedt's brother by selling
Lindstedt's mother's property in Newton County could accomplish this,
then so be it. The end result is that Cpl Oren Barnes wrote Martina
Lindstedt's death warrant at around 4:36pm February 18, 2013.

3. No guardian ad litem has any "immunity" for conspiring with the very person embezzling an estate of a person needing legal protection to enable that embezzling and eventual murder. Micheal Lindstedt has admitted to Pastor Lindstedt several times that Terry Neff told him that he didn't have to return Martina Lindstedt from where Mike had kept her 800 miles away in Midland SD since May 2009 to face competency evaluations and thus ending his guardianship and embezzling. Whether Mike Lindstedt and Terry Neff engaged in a criminal conspiracy in order to defeat guardianship process in Missouri is a matter of fact to be tried by jury. Thus the corrupt fruits of that conspiracy, i.e., the idiotic dismissal Motion to Dismiss drafted by Neff as appointed guardian ad litem do not confer limited or any immunity.

4. No judge has "absolute immunity" absent jurisdiction, especially given that the Revised Statutes of Missouri (RSMo) § 472.060 say that upon Petition and Affidavit of an interested party alleging bias and prejudice that the probate judge (Kevin Lee Selby) is to be removed from hearing the case and the presiding judge (Timothy Perigo) is to assign a different judge. No judge has "immunity" to violate the very law the judges are sworn to uphold and obey. Thus neither judge had any "discretion" whatsoever under which to claim immunity. This is true not only the first time but the second and third time as well. Assistant Missouri Attorney General Brandon Laird lied when he claimed that Judges Kevin Lee Selby and Timothy Perigo had "discretion" to knowingly and willfully violate Missouri probate law and thus were performing a "judicial function" by this lawlessness in refusing to obey Missouri probate law. The district court also was a party in agreeing with this lie.

5. No police officer has any immunity for threatening a false arrest in order to attain a criminal result, such as Cpl. Barnes threatening Pastor Lindstedt with a false arrest. This behavior was seen as proof positive by Defendants Michael Lindstedt and Crystal Courtney that they could continue to embezzle Martina Lindstedt's estate and if necessary murder

Martina Lindstedt because Newton County and the Newton County
Sheriff's Department had a policy of treasonous harassment and violation of
civil rights to force Pastor Lindstedt out of Missouri in general and Newton
County in particular. Thus Cpl Barnes and Sheriff Ken Copeland committed
terrorism and solicited the eventual murder of Martina Lindstedt.

STATEMENT OF THE CASE & STATEMENT OF FACTS RELEVANT TO THE ISSUES PRESENTED FOR REVIEW

1. Pastor Martin Lindstedt sided with Michael Lindstedt against their sister, Susan Lindstedt-Rohde in the division of the Jenny Samuelson Estate (Martina Lindstedt's mother, Lindstdt's grandmother) back in 1999 in South Dakota of 8400 acres and \$800,000 of which \$520,000 went to state and federal inheritance taxes and lawyer's fees leaving \$153,000 for Martina Lindstedt along with a life estate of a fifth of the land or 1600 acres. The will provided that upon Martina Lindstedt's death, her land in South Dakota would go to Mike Lindstedt and the deceased Monte Lindstedt's two children. The agreement was made with Mike Lindstedt for him to split up half of Mike's half with Martin Lindstedt and it was assumed that Susan had a similar agreement with Monte's bunch. This agreement was made because Mike had poisoned Pastor Lindstedt against Susan and Monte's widow.

The Jenny Osbourne Samuelson side of the family has a tendency to kill their husbands or mothers in order to inherit. Jenny murdered her husband Martin Samuelson who made the fortune and used the lawyers who

became judges in South Dakota to get away with theft and murder. Likewise, Michael Lindstedt would also steal from his mother's estate and kill her through neglect in order to cover up the embezzlement on April 5, 2013. However, Michael Lindstedt was able to do it cheap due to the animus against Pastor Lindstedt from the Newton County Sheriff's Department, Judges Kevin Lee Selby and Timothy Perigo, and the idiocy of Attorney Terry Neff and not have to pay the bribes that Jenny Samuelson did. Murdering hubands and mothers and paying off the crooked authorities is an Osbourne tradition and is bred into the bone, sort of like the Scotsmen in Robert Louis Stevenson novel "Kidnapped." The Osbournes are Strathelyders and lowland Scots.

2. After Pastor Lindstedt defeated the bogus child molestation charges made by the Newton County authorities, especially Judge Kevin Lee Selby and Sheriff Ken Copeland in Feb. 2009, Mike Lindstedt decided to take Martina Lindstedt from her home on a farm around Granby Missouri to his house in Midland SD, 800 miles away. Mike Lindstedt had gotten the initial \$153,000 plus around \$12,000 per year after property taxes since 1999 to 2009, or ten years. When confronted about why Mike had moved Martina away from her home, Mike Lindstedt told Pastor Lindstedt that Mike wished that Pastor Lindstedt had been convicted for life on the child molestation charges so that Mike Lindstedt could do with Martina's estate as Mike pleased, and that Martin was no longer allowed to enter the double-wide trailer house at 378 Rabbit Track Road in Granby that they both jointly owned. Pastor Lindstedt allowed this because Terry Bessman, Susan Lindstedt's first husband was still alive.

- 3. In Nov. 2012, after Terry Bessman's death, Pastor Lindstedt apologized to Susan Lindstedt for cutting her out of Martina's life by siding with Mike. Mike heard this and panicked and decided to sell Martina's house in Newton County to prevent Pastor Lindstedt and Susan Lindstedt from returning Martina Lindstedt. On Feb. 16, 2013, Mike announced to Pastor Lindstedt that Mike was selling Martina Lindstedt's house.
- 4. On Feb. 18, 2013, Mike Lindstedt was planning on selling their mother Martina Lindstedt's farmhouse just outside Granby so that Martina Lindstedt wouldn't be able to return to her home and have her affairs watched over by Pastor Lindstedt and their sister Susan Lindstedt-Rodhe. Mike Lindstedt had stashed Martina at his house in Midland SD over 800 miles away so that he could embezzle her estate as he had Martina's guardianship. Susan Lindstedt called the Newton County Sheriff's Department because Mike had a history of violence against Pastor Lindstedt. When the Sheriff's Department arrived, Corporal Oren Barnes of the Newton County Sheriff's Department (now a police instructor at Crowder College in Neosho) said that Martina Lindstedt got to decide whether to sell her house. Upon getting in touch via Mike's cell phone only Mike had the number to his house in Midland – Martina Lindstedt said five times that "she didn't know about selling the house." Upon hearing this, Corporal Barnes threatened to arrest Pastor Lindstedt if he didn't leave. There is an audio recording to this effect. The audio recording proves that Cpl Barnes didn't even know Mike Lindstedt, and that there was a policy by the Newton County Sheriff's Department to drive Pastor Lindstedt out of Newton County due to a bogus child molestation case which had to be dismissed after sending Pastor Lindstedt to a psychiatric prison to be doped

up and tortured. There is a state of civil warfare between Pastor Lindstedt and Lindstedt's Church and the Newton County authorities. Whereupon a federal civil rights lawsuit was filed under 42 U.S.C. § 1983. The main purpose of the lawsuit was to prevent Mike Lindstedt from selling the farmhouse or farm and thus by doing so eliminate the only way to keep enough Missouri assets over \$15,000 so as to change the guardianship of Martina Lindstedt. The lawsuit was successful in that it kept Mike Lindstedt and the auctioneer from selling Martina Lindsted's house and farm.

- 5. While the farm was temporarily safe, Pastor Lindstedt convinced Susan Lindstedt-Rohde to file for a mental evaluation of Martina Lindstedt to bring her back from 800 miles away in Mike Lindstedt's house in South Dakota and end Mike Lindstedt's sole power of attorney. So on Feb. 28, a case was made to bring Martina Lindstedt down to Missouri, where with the mentality on a good day of a ten-year-old girl, a new guardianship could be made with a more equitable division sof the Martina Lindstedt estate of 1600 acres worth \$1.9 million and what should be \$300,000 cash. Judge Kevin Lee Selby appointed Terry Neff, the stupidest lawyer in Newton County to act as guardian ad litem. Jacob Skouby, Newton County Prosecutor admitted that someone in the probate division of Selby's notified Michael Lindstedt via phone about the guardianship process and Mike Lindstedt, two cars behind Pastor Lindstedt and Susan Lindstedt's pickup at the Sonic in Neosho high-tailed it to South Dakota without getting his drinks at the drive-through.
- 6. Mike Lindstedt has numerous times admitted that Terry Neff told him that he didn't have to bring Martina Lindstedt back to Newton County

for the guardianship proceedings because Neff would "fix it". Terry Neff is not only stupid, but has all the moral firmness of a wet noodle. While it is doubtful Neff conspired with Mike Lindstedt to kill Martina Lindstedt, Neff's stupidity got Martina killed by Mike nevertheless.

- 7. Martina Lindstedt died in Mikes house in Midland all alone like an animal on April 5, 2013 800 miles from her home and five days before the guardianship proceedings in Newton County scheduled for April 10, 20113.
- 8. Driving the 800 miles to Phillip SD to pick up Martina's body for burial in Granby Missouri, Mike Lindstedt admitted to Pastor Lindstedt that Martina Lindstedt had been deprived of her blood pressure medicine and literally scared to death about what Pastor Lindstedt and Susan would do to her, i.e. put her in a nursing home and take all her money. Pastor Lindstedt made funeral arrangements and officiated at Martina Lindstedt's funeral.
- 9. With Martina Lindstedt dead and only \$40,000 worth in real estate in Newton County, Pastor Lindstedt didn't want to open probate before Judge Kevin Lee Selby but Missouri requires all wills be produced within a year, so Pastor Lindstedt waited until the last minute to file for probate in Missouri on April 3, 2014.
- 9. Since then Judge Kevin Lee Selby has threatened to put Pastor Lindstedt in jail or the Fulton State Nuthouse for contempt. So Pastor Lindstedt filed against the two crooked judges and idiot attorney via amended complaint in Sept. 2015. The district court claims that Missouri judges don't have to obey Missouri law. Judge Selby and Perigo still refuse to obey these Missouri probate laws, as recently as March 30, 2016.
- 10. On April 4, 2016, Mike Lindstedt admitted to Pastor Lindstedt that there is only \$20,000 left of Martina's money and that the law firm in South

Dakota refuses to handle probate in South Dakota for fear of being sued as accessories to theft and murder by Pastor Lindstedt. Mike and Crystal stole over \$280,000 over the past 15 years.

SUMMARY OF THE ARGUMENT

Plaintiffs make the argument that Defendants Michael Lindstedt and Crystal Courtney moved Martina Lindstedt to Michael's house in Midland South Dakota in May 2009 so that they could loot Martina Lindstedt's estate of \$300,000+ in order to keep Pastor Martin Lindstedt and Susan Lindstedt-Rohde from stopping this enbezzzlement. Upon re-approachment with Susan Lindstedt, Mike and Crystal panicked and decided to sell Martina Lindstedt's farmhouse so that she never could return to Missouri. On Feb. 18, 2013, upon the Newton County Sheriff's Office being called by Susan Lindstedt to the farm to protect Pastor Lindstedt from an agitated Mike Lindstedt, Corporal Barnes of the Newton County Sheriff's Department along with another sheriff's deputy in another SUV, decided to get involved in the dispute over selling Martina's home. Upon contacting Martina Lindstedt by Mike's cell phone – Mike wouldn't allow anyone else to know Martina's landline telephone number - Mike Lindstedt claimed that it had already been arranged to sell the house – Martina Lindstedt kept on saying "Mike, I don't know" five times, and expressed a desire to return to her home in Missouri. Since Cpl Barnes had already stated, "Whatever Martina Lindstedt says goes" then upon Martina Lindstedt expressing an unwillingness to sell, proceeded to find another excuse to harass Pastor Martin Lindstedt and ended up threatening Pastor Lindstedt with false arrest

and upon being driven out Cpl Barnes stayed behind presumably to further conspire with Mike Lindstedt and Crystal Courtney, who used to work for the Newton County Sheriff's Department until being let go for being brutal even by Newton County standards upon prisoners.

Plaintiffs' Response to Order to Show Cause of Nov. 3, 2015 (Document #61) has a relevant transcript of above audio recording. It shows that Cpl. Barnes didn't know who Mike Lindstedt was, knew all about Pastor Martin Lindstedt and Lindstedt's previous illegal incarceration in the Fulton State Nuthouse on the bogus child molestation charges which had to be dismissed and that the Newton County Sheriff's Department had a policy of doing whatever it took to force Pastor Lindstedt out of Newton County. The end result was that Mike Lindstedt and Crystal Courtney took this as implied permission to continue looting Martina Lindstedt's estate in South Dakota and in Missouri and a permission slip to even murder Martina Lindstedt and the Newton County Sheriff's Department would not investigate further as they were only interested in repression under color of law against Pastor Martin Lindstedt. At approximately 4:36pm Feb. 18, 2013 Martina Louise Samuelson Lindstedt's death warrant was written by Corporal Oren Barnes of the Newton County Sheriff's Department acting under policy of Sheriff Ken Copeland and Newton County to do whatever it took to drive Pastor Lindstedt out of Newton County Missouri.

This is genuine material fact and a complaint upon which should be brought to trial by jury given this recording and transcript. None of the original Defendants (Michael Lindstedt, Crystal Courtney, Cpl Oren Barnes, Sheriff Ken Copeland, Newton County, Newton County Sheriff's Department) have given much of a defense to these facts and the original or amended civil complaints. Yet Judge Stephen Baugh claims that he sees no complaint upon which relief can be granted.

CONCLUSION – RELIEF SOUGHT

Judicial murder by criminal regimes is nothing new. In the 9th Century B.C. a competent Israelite king named Ahab with a nagging Canaanite wife named Jezebel came up with a scheme to steal a vineyard and then to murder a godly Israelite named Naboth, along with Naboth's family so that Ahab could inherit under color of law. (I Kings Chapter 21). YHWH sent Elijah to tell Ahab that as had already been done with the Houses of Jereboah and Baasha and was to be done in turn with the Houses of Jehu, and other warlords until Israel was deported by the Assyrians.
