OK, Bryan Reo has filed a federal lawsuit against myself in forma pauperis pro se. Which means that I can't get a copy of the lawsuit until I am served, and I can't be served until a judge grants this status to let Reo sue for free. If this judge grants Reo such status, which is doubtful. I called up to the Cleveland US District Court, but the clerk refused to send me even the docket sheet, telling me that I wouldn't get it until a judge grants Reo's in forma pauperis, which if it is like the lawsuit Reo threatened with me and CrisisHost, probably isn't going to happen. I got a pretty good idea as to what the litigation looks like because I got an e-mail from Reo dated April 18th, which was likely dated ten days from my Counter-Notice over at CrisisHost, and not from DreamHost.

So I got a PACER account, but there is no record of Reo's lawsuit, probably because there is no lawsuit until a federal judge says that there is a lawsuit if he allows Reo to file as a pro se indigent. Given Reo's past history of making fraudulent DMCA notices and abuse of process, there is a good chance that the judge will look at Reo's delusional blitherings and tell Reo to pay out the \$350 docket fee and plus service.

The problem that I have is that now Reo can pretend that its time still tolls because it did file, even though against me being on CrisisHost, in a timely manner and that the judge didn't deny Reo's suit but rather Reo getting to file it for free. Thus Reo could, and knowing Reo, would claim that I'm still violating its copyright until this matter is settled.

So I suppose that I'll have to file a Motion under 28 USC Section 1915 notifying the judge that Bryan Reo has been stalking me and others and using the DMCA process to censor and harass web page owners, that 99.999% of my material doesn't have anything to do with Bryan Reo, and that the DMCA complaints involve nothing more than me finding out Reo's name and Facebook and Xuqa.com public profile pictures and publishing them showing that Reo isn't even remotely white. I'll ask the judge to not only to dismiss the lawsuit because of Reo's inability to proceed cogently, and with assets to seize when the suit is proven bogus, but to disallow any further DMCA copyright litigation by Reo and an injunction allowing me to openly publish these Reo pictures.

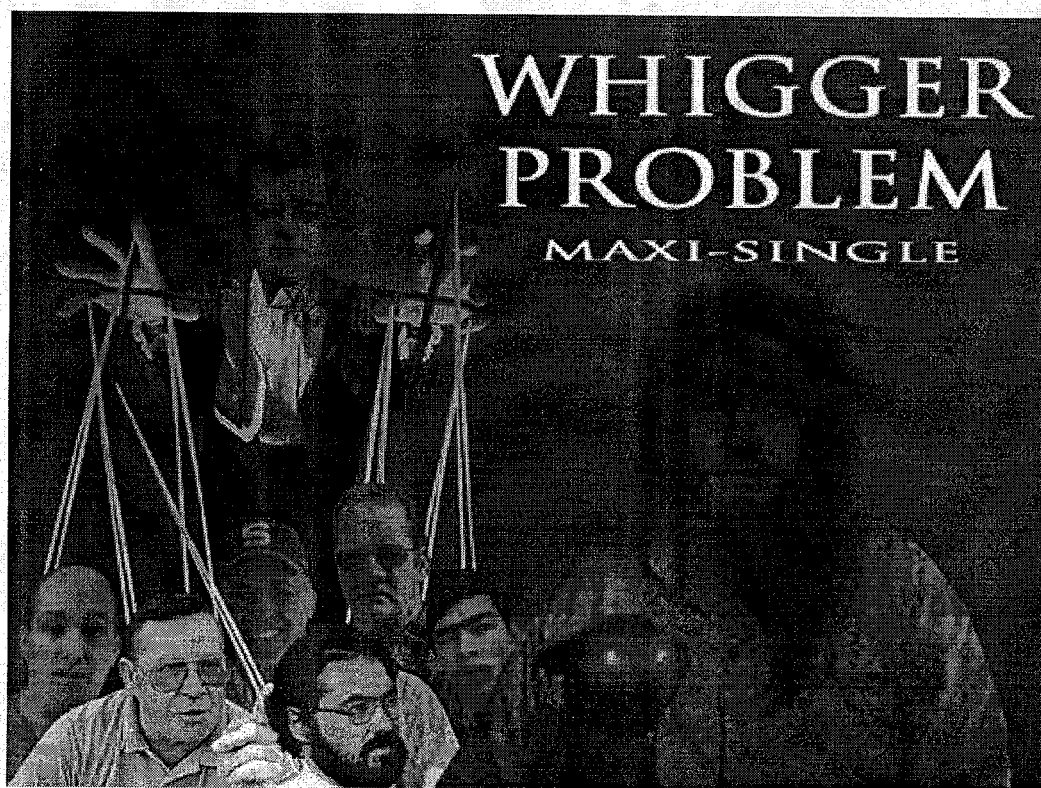
