07/07/2015	42	ORDER TO SHOW CAUSE: On 4/16/2014, pro se Plaintiff Brian Anthony Reo, a Ohio resident, filed his complaint <u>1</u> against Defendant Martin Lindstedt, a Missouri resident, in the Northern District of Ohio. The action was transferred to this district as the proper venue pursuant to 28 U.S.C. sec. 1406(a) in an order dated 6/13/2014. Plaintiffs complaint asserts claims under the Digital Millennium Copyright Act (DMCA), 17 U.S.C. sections 1201 et seq., as well as claims arising under state tort law. Plaintiff contends Defendant "is engaged in cyber–stalking, defaming, and impersonating Plaintiff on the internet" as a part of Defendants "relentless campaign of harassment" against him. [1 at 3–4]. Plaintiff seeks injunctive relief and \$10,750,000 in monetary damages, including: \$100,000 in actual damages "for damage to Plaintiffs reputation", \$500,000 in emotional damages, \$10,000,000 in punitive damages, and \$150,000 in statutory damages pursuant to the DMCA. [1 at 12–14]. Plaintiff was previously given leave to proceed in forma pauperis <u>6</u> . Under 28 U.S.C. sec. 1915(e), the Court is required to review complaints proceeding in forma pauperis to determine if dismissal is appropriate. Pro se pleadings are to be liberally construed and "held to less stringent standards than formal pleadings drafted by lawyers". Erickson v. Pardus, 551 U.S. 89, 94 (2007). Upon review, even with the Courts liberal construction, the allegations in the complaint are insufficient to establish federal jurisdiction. The Plaintiff fails to state a plausible claim for relief under the DMCA to establish federal question jurisdiction under 28 U.S.C. sec. 1331. See Bell Atlantic Corp. v. Twombly, 550 U.S. 544, 570 (2007) (where "plaintiffs have not nudged their claims across the line from conceivable to plausible, their complaint must be dismissed"). Further, Plaintiffs assertions are insufficient to support the legitimacy of a claim exceeding \$75,000, the amount–in–controversy requirement to establish diversity jurisdiction under 28 U.S.C. sec. 1332. See Missouri ex rel. Pemiscot County v. Western Sur. Co., 51 F.3d 170, 173 (8th Cir. 1995) ("when a federal complaint alleges a sufficient amount in controversy to establish diversity jurisdiction, but... the court questions whether the amount alleged is legitimate, the party invoking federal jurisdiction must prove the requisite amount by a preponderance of the evidence."). "If the court determines at any time that it lacks subject–matter jurisdiction, the court must dismiss the action." Fed. R. Civ. P. 12(h)(3). IT IS THEREFORE ORDERED that the Plaintiff is directed to show cause in writing by no later than 7/27/2015 why this case should not be dismissed for lack of subject matter jurisdiction.
